Terms, Conditions, and Limitations

This warranty covers the **NANOROOF™ Sealer SPS** system for 15 years, including materials and labor provided by a certified **NANOROOF™** applicator/contractor, when applied per **NANOROOF™** Technical Specifications.

Access for Inspection: **NANOROOF™** or its representative may inspect the roof during normal business hours throughout the warranty term to ensure compliance.

Warranty Period: The Warranty Period begins on the date installation of the **NANOROOF™ Sealer SPS** system is completed and shall remain in force for the period of time identified in the Installation Contract.

Warranty: If the **NANOROOF™ Sealer SPS** system fails during the Warranty Period, **NANOROOF™**, in its sole discretion, will either provide materials and labor for a certified **NANOROOF™** applicator/contractor to reapply or repair the system or issue a credit in an amount equal to the cost you paid for installation of the **NANOROOF™ Sealer SPS** prorated by the remaining warranty term toward a new asphalt shingle roof installed by a **NANOROOF™**-approved roofing company.

Notification: The property owner must notify **NANOROOF™** by email to warranties@nanorooftm.com within 5 days of discovering significant deterioration or defects and include photographs showing the deterioration or defects. Failure to provide timely notice voids this warranty.

Exclusive Remedy: This warranty provides the sole remedy for system failure, covering materials and labor as specified. **NANOROOF™** is not liable for incidental or consequential damages, including personal injury, building damage, or mold-related issues.

Disclaimer of Warranties: Except as expressly stated, **NANOROOF™** disclaims all other warranties, express or implied, including implied warranties of merchantability and fitness for a particular purpose. No representative is authorized to make additional warranties.

Exclusions: This warranty does not cover damage, deterioration, or failure caused by:

- Normal wear, tear and exposure to the elements
- Natural disasters and acts of God, including but not limited to lightning, hail, high winds, hurricanes, tornados, and earthquakes
- Vandalism, war, terrorism, or civil disturbances
- Unauthorized roof alterations or installations without prior written consent
- Harmful environmental conditions or chemicals (e.g., solvents, acids, oils)
- Neglect
- Failure to reasonably maintain the roof
- Debris accumulation
- Failure to timely complete necessary repairs
- Excessive foot traffic on the roof
- Actions by unauthorized third parties (e.g., contractors not approved by **NANOROOF™**)
- Insect or animal infestations
- Poor roof ventilation or the failure to implement roof ventilation recommendations provided by **NANOROOF™**
- Structural and roof design defects
- Leaking and water intrusion.

Transferability: This warranty may be transferred to a new property owner, provided, however, such transfer will not extend the original Warranty Period. The transfer must be recorded with **NANOROOF™** within 30 days of property ownership transfer to remain valid.

Governing Law and Dispute Resolution: Claims or disputes under this warranty or related to the **NANOROOF™ Sealer SPS** system are governed by Florida law and resolved through binding arbitration in West Palm Beach, Florida, according to the American Arbitration Association's rules.
